CLEANSING NOTICE

Arizona Lithium Limited (ASX: AZL) (“Arizona Lithium” or the “Company”) issued 200,000,000 ordinary shares as security for the At-the-Market Facility announced today and as noted in the Company’s Appendix 2A’s of today’s date.
