**CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT**


As announced on 1 May 2024, W.A Kaolin Limited (Company) secured a two-tranche placement to raise approximately \$7m (before costs) for its Wickepin Kaolin Project located in Wickepin, Western Australia.

The Company has now received the first tranche of \$2.05m and has issued 34,200,001 fully paid ordinary shares in the capital of the Company at an issue price of \$0.06, as well as 8,550,000 unquoted options (expiring 30 June 2027 with an exercise price of \$0.09). The related Appendix 2A and Appendix 3G were lodged on 7 May 2024.

The Company gives notice pursuant to section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that:

1. the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
2. as at the date of this notice, the Company has complied with:

  - b) section 674 of the Corporations Act; and
