



VIRTUAL MEETING GUIDE

Important information in regard to Annual General Meeting voting

The Annual General Meeting (Meeting) of shareholders of Jade Gas Holdings Limited (ACN 062 879 583) (**Company**) (ASX: JGH) will be held on Friday, 31 May 2024 at 10:30 am (ACST) via a live webcast from the Company's registered office, further details of which are set out below. **Shareholders are strongly encouraged to either vote prior to the Meeting or to appoint the Chair of the Meeting as their proxy.**

All resolutions at the Meeting will be voted on by poll (rather than a show of hands) and shareholders who are entitled to vote may vote either prior to the Meeting by appointing a proxy or by poll during the Meeting.

Further details of the voting methods open to Shareholders are set out in detail below.

Voting by Proxy

Shareholders are strongly encouraged to appoint the Chair of the Meeting as their proxy. Shareholders can complete the proxy form to provide specific instructions on how a Shareholder's vote is to be exercised on each item of business, and the Chair of the Meeting must follow their instructions. Lodgement instructions (which include the ability to lodge proxies electronically) are set out in the proxy form despatched to all shareholders.

Proxy votes must be received by **10:30 am (ACST) on Wednesday, 29 May 2024.**

Voting by Poll

Shareholders who do not wish to vote using a proxy form and who intend to vote on a poll at the Meeting must contact the Company at meetings@jadegas.com.au to notify the Company of their intentions and to request a personalised poll form. Notifications must include the Holders Name, Address and HIN or SRN.

Shareholders will be able to submit their email poll votes via meetings@jadegas.com.au immediately after the Chair calls for a vote on the Resolution and up to a period of one hour after the Meeting ends. This means that the outcome of each Resolution will not be able to be determined until after the conclusion of the Meeting to allow the Company Secretary sufficient time to count such poll votes submitted by email.
