DEPLOYMENT AT THE FIRST HARDI AGED CARE SITE MOVES FROM PILOT TO FULL SITE ROLL-OUT

- Following a successful pilot phase, Hardi Aged Care ("Hardi") is now moving forward with full site implementation at the Manly Vale facility.
- Implementation of InteliCare in 42 rooms at Blacktown, Hardi's second site, will now be brought forward to occur concurrently with the Manly Vale implementation.

InteliCare Holdings Ltd ("ICR" or the "Company") (ASX: ICR), an Australian Software-as-a-Service (SaaS) technology company commercialising its proprietary AI driven InteliCare platform (InteliCare) in the aged care, disability and health sectors is pleased to announce the 10-bed deployment at the Hardi Aged Care Manly Vale facility will now expand to a full site rollout. In addition, the deployment of InteliCare into 42 single rooms at the Blacktown facility, Hardi's second site has been brought forward to occur at the same time.

InteliCare and Hardi entered into a binding Subscription Agreement on 27 February 2024 to deploy InteliCare into Hardi's six (6) residential aged care facilities, supporting almost 600 residents. The deployment across these six facilities is expected to take approximately nine months.

I am really excited that we are also able to support Hardi in bringing forward the implementation of InteliCare in 42 single rooms at the second site in Blacktown to occur at same time as the Manly Vale facility."
