## Notice Under Section 708A(5)(e) of the Corporations Act

On 23 May 2024, Resource Mining Corporation Limited (ASX:RMI) (RMI or the Company) has issued a total of 10,000,000 fully paid ordinary shares at \$0.10 per share in accordance with the terms of its Share Swap Agreement which was announced to ASX on 11 January 2023.

The shares were issued under the Company's existing placement capacity under 7.1 of the ASX Listing Rules.
