**NOTICE TO ELIGIBLE SHAREHOLDERS OF RUMBLE RESOURCES LIMITED PRO-RATA NON-RENOUNCEABLE ENTITLEMENT ISSUE**

On 10 May 2024, Rumble Resources Limited (**ASX: RTR**) announced a pro-rata non-renounceable entitlement issue of one share for every ten shares held by those shareholders registered at the record date, 7:00pm (AEST) Tuesday, 21 May 2024 (**Record Date**) at an issue price of \$0.04 per share to raise up to approximately \$2,921,577 (before costs) (**Entitlement Offer**).
