## NOTICE OF SECOND COURT HEARING TO APPROVE SCHEME OF ARRANGEMENT UNDER SECTION 411 OF THE CORPORATIONS ACT

Greenstone Resources Limited (ASX: GSR) (the **Company** or **Greenstone**) refers to the orders of the Honourable Justice Hill made on 30 April 2024 (**Orders**).

Pursuant to the Orders and section 411(4)(b) of the *Corporations Act 2001* (Cth) (**Corporations Act**), attached is the notice of hearing of an application to approve the proposed schemes of arrangement pursuant to which Horizon Minerals Limited (ASX: HRZ) has agreed to acquire all of the shares in the capital of Greenstone (**Share Scheme**) and all of the listed options in the capital of Greenstone (**Option Scheme**), as announced on 13 February 2024 (together, the **Schemes**).
