



Notice under Section 708A of The Corporations Act 2001 (Cth) (Act)

Further to the announcement on 6 June 2024, Ausgold Limited ("Ausgold") gives notice of the following under section 708A (5)(e) of the Act:

1. Ausgold issued 466,000,000 fully paid ordinary shares (**Shares**), at an issue price of \$0.03 per share to sophisticated investors on 14 June 2024;
