

Share Purchase Plan Update

Provaris Energy Ltd (ASX.PV1) (Provaris or **the Company)** provides an update in relation to the Share Purchase Plan (**SPP**). Given the ongoing development of a schedule to recommence and complete the prototype tank, the Board is electing to decrease the amount to be raised under the SPP to \$1 million.

The underwriters of the SPP, being existing major shareholders of Provaris, remain committed to funding any shortfall in SPP subscriptions below the revised SPP amount of \$1 million.

The reduced SPP amount and Provaris' current cash on hand are considered sufficient while Provaris continues to progress commercial agreements related to the ongoing development of hydrogen supply chains in Europe based on the Company's hydrogen storage (tanks and barges) and marine carriers, whilst also finalizing a proposal to recommence work on the prototype tank.

The Board would like to thank Shareholders for their ongoing support and participation to date in the SPP.
