**SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001
("Act")**

On 4 July 2024, Brookside Energy Limited (**Company**) issued 8,333,333 fully paid ordinary shares in the capital of the Company (**Shares**) following the exercise of share rights held by Mr Gracjan Lambert.

 - (B) The rights and liabilities attaching to the Shares.
