# **CDI Voting Instruction Form - Shareholders' Scheme Meeting**

Capitalised terms used but not defined in this CDI Voting Instruction Form have the same meaning as given to them in Civmec Limited's Circular which can be accessed on Civmec Limited's announcement platform at www.asx.com.au and on Civmec Limited's website https:// www.civmec.com.au/investors/announcements/ (unless the context requires otherwise).

#### How to Vote the Item of Business

Each CHESS Depositary Interest (CDI) is equivalent to 1 (one) share of Company Common Stock, so that every 1 (one) CDI registered in your name at 25 July 2024 entitles you to one

You can vote by completing, signing and returning your CDI Voting Instruction Form. This form gives your voting instructions to CHESS Depositary Nominees Pty Ltd, which will vote the underlying shares on your behalf. You need to return the form no later than the time and date shown above to give CHESS Depositary Nominees Pty Ltd enough time to tabulate all CHESS Depositary Interest votes and to vote on the underlying shares.

A CDI holder may only cast all the votes he/she/it has in respect of the shares underlying his/ her/its holding in the Company in one way, and may only:

- a. cast his/her/its votes "for" the Shareholders' Scheme;
- b. cast his/her/its votes "against" the Shareholders' Scheme; or
- c. abstain from voting.

Each CDI holder that directs CDN to vote the shares underlying their holding and for which CDN subsequently submits a Proxy Form for appointing the Chairman of the Shareholders' Scheme Meeting to attend, speak and vote the shares underlying its holding in the Company shall be deemed to be present at the Shareholders' Scheme Meeting and shall be included in the count of the Shareholders present and voting at the Shareholders' Scheme Meeting. Where more than one (1) CDI holder has provided their direction to CDN and for which CDN has appointed the Chairman of the Shareholders' Scheme Meeting to attend, speak and vote at the Shareholders' Scheme Meeting, the votes of the Chairman of the Shareholders' Scheme Meeting shall be counted as the votes of the number of appointing CDI holders.
