Summer drilling campaign commences at Falcon Lake

Drilling re-commences to test multiple newly identified targets across the highly prospective 5km long corridor at Falcon Lake

Highlights:

- Drilling program will aim to expand on the successful 2023 drilling programs, which returned significant high-grade intercepts including:
 - o 31.75 metres @ 1.45% Li₂O (23FL-031)
 - o 27.6 metres @ 1.37% Li₂O (23FL-001)
 - o 21.9 metres @ 1.44% Li₂O (23FL-004)
 - o 20.65 metres @ 1.48% Li₂O (23FL-081)
 - o 18.95 metres @ 1.65% Li₂O (23FL-076)
- Drill targets have been prioritised across the 5km mineralised corridor at the Falcon Lake Lithium Project, with the program designed to unlock the broader potential of the asset.
- Drilling will be undertaken by the Rodren Drilling Whitesand First Nation JV, a
 joint venture between BM8's incumbent drilling contractor and the local First Nation
 group.

Battery Age Minerals Ltd (ASX: BM8; **Battery Age** or **the Company**) is pleased to advise that drilling activities have re-commenced at its Falcon Lake Lithium Project in Ontario, Canada.

Battery Age has remobilised personnel to Falcon Lake to oversee the drilling program. The program has been designed to further delineate and expand the high-grade lithium zones identified last year, as well as to test new pegmatite discoveries within other high-priority zones across the 5km mineralised corridor.

The drilling program has been designed and prioritised based on the results of the 2023 and 2024 summer field exploration campaign, which included lidar, ortho-imagery, ground magnetics, prospecting, rock chip sampling, and litho-geochemical transects across the Falcon Main tenure.




Figure 2 – Prioritised 2024 drill collars designed on 2023 and 2024 field program results at Falcon Lake.

We are also proud to continue our collaboration with the Rodren Drilling-Whitesand First Nation JV, ensuring that our operations benefit the local communities. We look forward to reporting on the results from this drill program."
