

Cleansing Notice

Rincon Resources Limited (Rincon or **the Company)** (ASX: RCR) advises that it has issued and allotted 2,970,000 fully paid ordinary shares as detailed in the Appendix 2A released today.

Secondary Trading Exemption:

 - 2) The rights and liabilities attaching to the Shares.
