3Dicom for Veterans Initiative Expands to Texas

HIGHLIGHTS

- Purchase Order received from TechWorks4Good via US Master Distributor, CG1 Solutions, for 5,000 additional 3Dicom Patient licenses for US Veteran's in Austin, Texas.
- Positive traction in Florida with new marketing materials, streamlined digital ID verification for Veterans, and easier, scalable onboarding with online viewer and tutorials.

15 July 2024 – Singular Health Group Limited (ASX: SHG, "Singular Health", or the "Company") has expanded the previously announced 3Dicom for Veteran's initiative from the Miami-Dade County (see ASX Announcement: *First 3Dicom Enterprise Sale Received in United States, dated 11th January 2024*) to Austin, Texas following the receipt of a binding purchase order for 5,000 additional 3Dicom Patient annual licenses.

This purchase order from US-based intermediary TechWorks4Good, a 501(c) company in Florida, will see at least 5,000 veterans in Austin, Texas receive the 3Dicom Patient licenses, sponsored by local enterprise, to improve access to their medical imaging records to reduce costly duplicate medical imaging and eliminate delays in accessing care.

Following the launch of the online viewer (see ASX Announcement: *Launch of a Licensable Zero-Footprint 3Dicom Online Viewer, 12th June 2024)*, several technical improvements, and the development of supporting marketing activities and events, there has been positive traction in Florida which has supported the expansion of the 3Dicom for Veteran's initiative.

In collaboration with TechWorks4Good, CG1 Solutions, and their local partners and sponsors, Singular Health will be deploying the 5,000 annual licenses on similar commercial terms to the previously announced enterprise order commencing August 1st with a binding commitment to all 5,000 licenses and payment to be made in two equal payments six and twelve months after the commencement date with a total contract value of ~\$80,000 AUD.

Singular Health's Chief Commercial Officer, Martina Mariano PhD, said:

"As we have rolled out the 3Dicom Patient licenses in Miami, Florida, we've been buoyed by the positive and constructive feedback we've received from end-users, partners, and sponsors of the initiative."

"We are very pleased to be helping a further 5,000 Veterans to unlock the value in their medical images and look forward to further expansion as we look to provide the more than 18 million Veterans in the USA with our 3Dicom software that helps them benefit from faster, easier, and more portable access to their medical imaging, in line with the objectives of the PACT Act."
