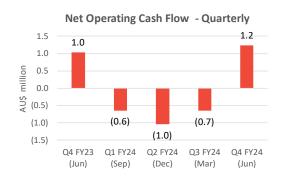
# June Q4 FY2024 Quarterly Activities Report

# **Highlights**

- In June K2fly entered a Scheme Implementation Deed with Argyle Bidco, a wholly owned subsidiary of Accel-KKR under which Accel-KKR will acquire 100% of the shares in K2fly by way of a Scheme of Arrangement for consideration of \$0.19 cash per share
- Annual Recurring Revenue (ARR)<sup>1</sup> of \$9.0m in Q4 FY2024, 20% higher than in Q4 FY2023 driven by new sales and contract renewals
- Revenue<sup>2</sup> of \$2.9m in Q4 FY2024, flat compared to Q3 FY2024 and lower than Q4 FY2023 due to the completion of implementation projects in prior periods resulting in lower implementation services revenues
- Cash receipts (\$4.6m) increased 28% over Q3 FY2024 (\$3.6m)
- Net Operating Cash in Q4 FY2024 was an inflow of \$1.2m, higher than Q4 FY2023, including the benefit of the implemented savings plan offsetting the impact of costs in relation to the strategic review. Net Operating Cash accretive in H2 FY 2024.
- New Resource Disclosure contracts were signed with Vale and Lundin Mining. Total new ARR of AU\$653k
- Cash balance on 30 June 2024 was \$2.4m increased from \$1.5m at the end of Q3 FY24. (\$2.0m working capital facility remains undrawn)

We focus on the operations of mining and asset intensive industries through our platform-based SaaS cloud solutions. K2fly is pleased to provide commentary regarding its activities for the June quarter, Q4 FY2024.







#### Nic Pollock CEO of K2fly said

"Q4 FY24 is a pivotal moment in the history of K2fly in our Software as a Service (SaaS) strategy. Despite flat revenue growth our core metric of ARR growth continued at 20% YoY as we continue to focus on landing and expanding our SaaS ARR license revenues.

We have seen significant new client acquisition and ARR in our Americas operations with the addition of two new name accounts (Vale and Lundin Mining) contracting onto the new Resource Disclosure platform for a combined AU\$653k in additional ARR. We also saw price growth (24%) in a multi-year contract renewal.

Our final quarter delivered a Net Operating Cash inflow of \$1.2m, consistent with our historical results which show a concentration of collections in Q4 due to the annual nature of our licence billing cycle and portfolio anniversary dates and including the benefit of our implemented savings plan.

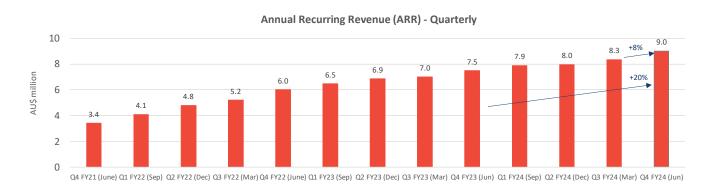
Finally, K2fly concluded our strategic review process that was commenced in November 2023. K2fly's globally unique and timely market offering, and strategy execution was recognised with a binding offer from Accel- KKR (Argyle Bidco) to acquire 100% of the shares in K2fly. The offer price of \$0.19 per share represents a 90% premium to K2fly's undisturbed share price as at June 20. The offer is unanimously recommended by the board and is supported by significant shareholders (Refer ASX announcement dated 21 June 2024).

The offer from Accel-KKR (when concluded) will provide K2fly with the best partner to continue the journey with our current and future customers to deliver net positive Resource Governance solutions for our current and future clients and a stronger company for our staff to continue to thrive."

#### CONTRACTS AND FINANCIAL RESULTS<sup>2</sup>

ARR grew 8% to \$9.0m compared to the end of the prior quarter up 20% compared to the end of **Q4 FY2023.** Total Contract Value (TCV) at the end of the quarter was \$17.0m.

Note: quarter-to-quarter movements in TCV include the net impact of new contracts and the depletion of existing contracts as the remaining term reduces and implementation milestones are achieved.



#### Revenue and Cash Receipts

Revenue during the quarter was \$1.9m down 2% over Q3 FY2024 and down 29% over Q4 FY2023 due to the completion of implementation projects in prior periods resulting in lower services revenues.

Cash Receipts from Customers are up 28% over Q3 FY2024 at \$4.6m and down 5% over Q4 FY2023.

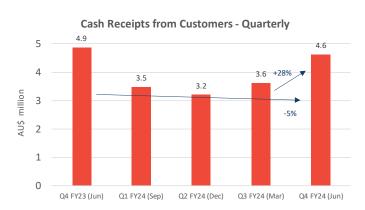






Note: the timing and collection of Cash Receipts throughout the year vary by month and quarter and are historically concentrated in the June quarter due to anniversary dates of annual contracts. Cash receipts are also influenced by timing of implementation progress against project milestones, and payment terms.



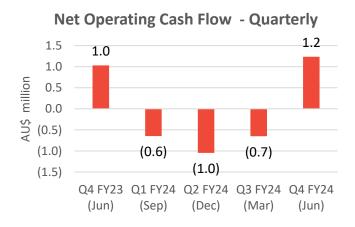


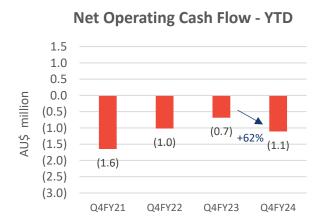
## **Net Operating Cashflow**

The June quarter generated a Net Operating Cash Inflow of \$1.2m, an increase from Q4 FY2023 despite the inclusion of \$0.2m of cost in relation to the strategic review due to the receipt of a \$0.3m R&D tax incentive and the benefit of the implemented savings plan. On full-year basis, compared to FY2023, Net Operating Cash Outflow increased 62% due to the cost of improvements in product development, inflation, costs in relation to the strategic review (\$0.3m), restructure costs associated with the implementation of the savings plan (\$0.2m) and general cost growth to support revenue.

Like the variability in the timing of annual fees, the Company incurs some annual costs which have a similarly variable profile. These contribute to overall variability on a quarter-on-quarter basis.

Gross Operating Expenditure (Section 1.2, Appendix 4C) in Q4 FY24 was \$3.7m, 14% lower than Q3 FY24 expenditure of \$4.3m and 5% lower than Q4 FY23, despite the inclusion of costs associated with the strategic review. Cost management remains a strong focus of the Company as the business scales.

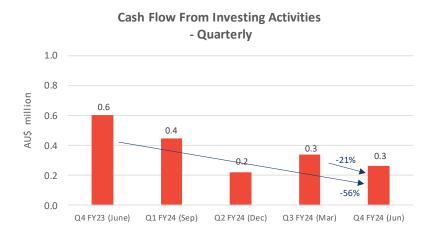






### **Investing Cashflow**

Investing cash outflows flows in Q4 FY24 were \$0.3m, 21% lower than Q3 FY24 and 56% lower than Q4 FY23 due to the completion of the Resource Disclosure development project.



#### Cost saving initiatives implemented

As previously disclosed, as part of its ongoing focus on cost management and emphasis on achieving operating cash breakeven, the Company has implemented a program of cost savings. Initiatives include staff redundancies (costs of \$0.2m settled in FY2024) and restructuring to improve operating effectiveness.

#### **OPERATIONAL UPDATE**

Whilst Q3 was notable for existing customer expansion Q4 has been a significant growth quarter for our Americas' division with two new name clients contracting our Resource Disclosure (RD) platform. Vale contracted RD in April 24 with a contract representing TCV of \$1.9m and ARR of AU\$473k over a three-year term. Vale, based in Brazil is the world's largest producer of iron ore, pellets and nickel, with operations in manganese, ferroalloys, copper, gold, silver, and cobalt. It is publicly listed on the São Paulo, New York City and Madrid stock exchanges. (Refer ASX announcement dated <a href="https://linker.com/linker.c

Lundin Mining also contracted to use RD with a Total Contract Value of AU\$661k and ARR of \$180k over a three-year term. Lundin is a diversified Canadian base metals mining company listed on the Toronto Stock Exchange (TSX) with operations and projects in Argentina, Brazil, Chile, Portugal, Sweden and the United States of America, primarily producing copper, zinc, gold and nickel. Another of our tier 1 clients renewed a multiyear (3 year) contract using our Mine Geology solution with a 24% increase in ARR

# **CORPORATE**

#### Strategic review

After undertaking the strategic review which was initiated in Q2 to evaluate options to realise the full business potential of K2fly and shareholder value (see ASX announcement <u>2 November 2023</u>, K2fly entered into a scheme implementation deed with Argyle Bidco Pty Ltd, a wholly owned

subsidiary of Accel-KKR under which Accel-KKR will acquire 100% of the shares in K2fly by way of a scheme of arrangement.

Under the scheme, K2fly shareholders will be entitled to receive \$0.19 cash per share which represents a 90% premium to K2fly's undisturbed share price of \$0.10 per share on 20 June 2024. The K2fly Board unanimously recommends that K2fly shareholders vote in favour of the Scheme in the absence of a superior proposal and subject to the independent expert concluding that the Scheme is in the best interests of K2fly shareholders.

Cash position: The Company held a cash balance on 30 June 2024 of \$2.4m (and \$2.0m in undrawn working capital facility available).

Operating expenditure: Cash outflows related to ongoing operating expenditures to run business operations and deliver K2fly's solutions to clients which include the key items of: R&D, product manufacturing and operating costs, advertising and marketing, staff costs and administration and corporate costs. Net Cash from Operating Activities was an inflow of \$1.2m (Section 1.9, Appendix 4C). Gross Operating Expenditure in the quarter ended 30 June 2024 amounted to cash outflows of \$3.7m (Section 1.2, Appendix 4C). See commentary section Revenue and Cash Receipts for further insight into K2fly's billing cycle.

**Net cash outflow from investing activities:** Outflows relate to investment in software development to enhance the current platform of solutions (\$208k), payments for the purchase of businesses (\$56k) being consideration relating to the purchase of Sateva and the acquisition of equipment (\$1k).

Payments to related parties and their associates: In accordance with ASX Listing Rule 4.7C.3, payments to related parties of the Company and their associates during the quarter totalled \$76k relating to Non-Executive Director fees. This amount is included at Item 6.1 of the Appendix 4C. Refer to the Remuneration Report in the 2023 Annual Report for further details on director remuneration.
