Noteholder debt remains held interest free until 31 December 2026. The debt balance as at 30 June 2024 was ~\$US16.17m (~\$A24.3m). The company expects to continue to repay this debt via instalments, using US\$ generated oil sales. The next repayment of \$US500k is expected to be made before the end of August 2024.

The Company continues to have in place a \$US5m facility (\$A7.548m) with major shareholder Waterford Finance & International Limited. This facility is provided interest fee, is unsecured and any funds drawn on the facility will be repayable on or before 31 December 2024, unless this date is extended by mutual agreement. The full \$US5m is currently available to the Company.
