ASX Announcement

Result of Meeting

In accordance with Listing Rule 3.13.2 and Section 251AA of the Corporations Act 2001, RLF AgTech Ltd (ASX: RLF) (RLF or the Company) wish to advise the following outcomes of the resolutions considered at the Company's General Meeting held earlier today.

Attached are the total number of votes in respect of validly appointed proxies and poll numbers.

All resolutions were passed by poll in accordance with Recommendation 6.4 of the 4th edition of the ASX Corporate Governance Council Principles and Recommendations.

The Directors of the Company are pleased that in respect of Resolution 1 (Removal of Kenneth Hancock as a director of the Company) there were 70 shareholders, who hold 103,950,081 shares, representing 45.3% of the shares on issue who voted in favour of removing Mr Hancock, whilst only 6 shareholders, who hold 7,151,062 representing 3.1% of the shares on issue who voted against removing Kenneth Hancock if the entitles related to Mr Hancock are excluded. The Board of the Company also notes that support for the removal of Mr Hancock was received in respect of a further 6,541,663 shares, representing 2.9% of the shares on issue but were not received in the timeframes required and were therefore excluded from the above numbers. Including these shares 48.2% of the shareholders supported the removal of Mr Hancock.

The Chairman of Board, Mr Don McLay commented:

"The Board fully supports its senior management and staff. Based on the energy, enthusiasm and outcomes achieved following the change in management, the Board is confident the Company is on a pathway to deliver on its new strategy and take the organisation towards its full potential."
