Loan facilities – In April 2024, Hastings Technology Metals Ltd organised insurance premium funding of \$445,237 at 7.7% per annum. The premium funding, held with Ledge Finance Ltd, is repayable in 12 equal monthly instalments with an end date of March 2024.		
Redeemable exchangeable notes - In October 2022, \$150,000,000 in secured, redeemable exchangeable notes were issued, convertible into ordinary shares of Hastings Technology Metals Ltd at an adjusted exchange price of \$4.91/note at the option of the holder, Wyloo Consolidated Investments Pty Ltd. The notes mature 11 October 2025, with interest accruing at the rate equivalent to the 3-month BBSY plus 9% per annum and to be paid-in-kind via the issue of additional notes on a quarterly basis subject to a cash payment election. To date \$36,799,000 in interest has been paid-in-kind.
