Note on Reverse Acquisition of DiscovEx Resources Limited by Latitude 66 Cobalt Limited

The transaction between DiscovEx Resources Limited (now Latitude 66 Ltd) and Latitude 66 Cobalt Limited was completed in June 2024. DiscovEx (the legal acquirer) obtained control of Latitude 66 Cobalt on 5 June 2024 being the date that the last of the material conditions precedent were satisfied. However, as a result of the acquisition, the former shareholders of Latitude 66 Cobalt effectively obtained control of the combined entity and Latitude 66 Cobalt was deemed the acquirer for accounting purposes. Therefore, the financial reports of the combined entity are presented as a continuation of Latitude 66 Cobalt (the accounting acquirer). Accordingly, the consolidated cashflows presented above include the cash flows of Latitude 66 Cobalt for the entire period as well as the cash flows of DiscovEx (now Latitude 66 Ltd) subsequent to the completion date of 5 June 2024 as well as the cash balance contributed by DiscovEx to the consolidated group on this date.
