No, the Company plans to continue with the reduction of net operating cash outflows over the next quarter and, the near future.

Yes, the Company has entered into a standby equity commitment with SBC Global Investment Fund which will provide up to A\$10 million in equity financing over a period of 36 months as announced on 21 July 2023. In addition, the Company has additional capacity to raise further funds under ASX Listing Rules. The Company continues to progress with further funding discussions and intends to meet its current planned activities and expenditure commitments.
