#### APPENDIX 4C AND REPORT ON QUARTERLY ACTIVITIES

Sydney, Australia, 31<sup>st</sup> July, 2024: Victor Group Holdings (ASX: VIG) ("VIG" or "the Company"), releases its cash flow report for the June 2024 quarter (Appendix 4C) and provides an update on the key areas of activity during the quarter ended 30 June 2024.

#### **Principal Activities**

VIG and its controlled entities (the "Group") provide:

- laaS, SaaS & PaaS services to customers;
- Education cloud platforms that bring together best-in-class resources and applications from strategic partners such as education service and e-learning content providers; and

#### Key areas of activity during the quarter:

- laaS, SaaS & PaaS service in PRC VIG operates its cloud services and software development in PRC through its subsidiary, Shenghan. During the quarter, Shenghan collected around \$5.53 million in trade receivables. The SaaS and PaaS services contributed a \$5.11 million cash inflow during the quarter. The software we delivered includes a Data management system, an ODS data centre system, and an Intelligent production line system. The company achieved a positive operating cash flow during the quarter. The collection of aged receivables also helped the company keep a stronger cash balance. The cash and cash equivalents position of Shenghan at the end of this quarter is \$1.33 million, which was \$598K higher than the last quarter. The management believes the cash flow from SaaS, laaS & PaaS will remain healthy in the next quarter.
- E-learning and cloud education the company collected \$424K in trade receivables from the E-learning business, while none of the new contracts were entered during the quarter. The company collaborated with many qualified and stable E-learning providers under new regulations of K12 education which helped the company promote its E-learning content on campus. The company also provided online courses for vocational training and skill sets, which followed the current trend of flexible employment in the local market. The management believes there will be further development in these areas, as the PRC government aims to improve the employment rate.
