EXERCISE OF UNLISTED PERFORMANCE RIGHTS

New World Resources Limited (ASX:NWC) (“the Company”) advises that it has issued 1,000,000 fully paid ordinary shares (“Shares”) pursuant to the exercise of 1,000,000 unlisted performance rights each of which had a 30 November 2025 expiry date.

Cleansing Notice

 - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) the rights and liabilities attaching to fully paid ordinary shares.
