The CGP has a 0.932 Moz gold Mineral Resource (see Table 3) defined in both oxide and deeper primary mineralisation with considerable potential to grow this resource with further drilling.

Patronus's exploration effort is the systematic program of exploration across the Cardinia Mining Centre that seeks to advance a number of targets in parallel while developing a pipeline of exploration targets for ongoing Mineral Resource expansion.
