## RocketDNA Extends Drone Services Deal with Anglo American Subsidiary

### HIGHLIGHTS

- RocketDNA has signed a multi-year contract with Rustenberg Platinum Mines Limited a subsidiary of Anglo American for its South African mining operations
- 2-year contract includes renewal of existing drone-based surveying services and the addition of new critical infrastructure security and monitoring
- Deal significantly expands the existing relationship and validates the commercial value of RocketDNA drone technology

8 August 2024, RocketDNA Ltd (ASX: RKT) (RocketDNA or the Company), a technology services company that leverages AI and Autonomous Drones to provide mission critical services for enterprise customers, is pleased to confirm that it has renewed and extended a contract with Rustenberg Platinum Mines Limited a subsidiary of Anglo American plc (**Anglo American** (LON:AAL)) for surveying and security services.

### Contract Overview

RocketDNA, through its subsidiary RocketDNA ZA Proprietary Ltd, has successfully renewed and extended an existing contract with Rustenberg Platinum Mines Limited, wholly owned by Anglo American. The Company has also secured additional services that substantially increase the existing partnership.

Key terms include:

- Provision of drone technology services across a number of South African based Anglo American mining operations, to deliver:
  - surveying data (stockpile data, monitoring of pits etc); and
  - security (monitoring of critical infrastructure).
- Total Contract Value (TCV) of A\$2.646m<sup>1</sup> / ZAR 31,883,841m
- Annual Recurring Revenue (ARR) of A\$1.176m<sup>1</sup> / ZAR 14.170m
- 2-year deal subject to termination of 90-days' notice and contains various other terms considered standard for agreements of this nature, expiring 31 October 2026.

Commenting on the partnership with Anglo American, RocketDNA CEO Christopher Clark said:

*"It is pleasing to see that our long-standing customer, Anglo American, continues to place its trust in RocketDNA to leverage our drone technology for mission critical data across its South African mining operations.*

*The endorsement also continues to provide important market validation for RocketDNA with respect to the high commercial value-in-use that our drone technology delivers to our customers.*
