

NOTICE UNDER SECTION 708(5)(e) OF THE CORPORATIONS ACT 2001

This notice is given by Vysarn Limited (**ASX: VYS**) (**Vysarn or the Company**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).
