RIGHTS ISSUE CLOSING DATE EXTENDED – DRILLING 80% COMPLETED

GTI Energy Ltd (ASX:GTR) (**Company**) advises that it has extended the Closing Date for the non-renounceable entitlement offer (**Entitlement Offer** or **Rights Issue**) from Monday, 9 September 2024 until Monday, 23 September 2024. The Closing Date for the Placement Option Offer, Broker Offer and Lead Manager Offer (as noted in the Prospectus dated 24 July 2024 and Supplementary Prospectus dated 29 July 2024) has also been extended to Monday, 23 September 2024.

FIGURE 1. LO HERMA PROJECT: DRILLING AREAS


Drilling at the Company’s 100% owned Lo Herma ISR uranium project in Wyoming’s Powder River Basin has progressed well to date.

Approximately 80% of the planned drill program is expected to be completed by the end of this week. Drilling thus far has been delivered within both the scheduled time and allocated budget.

Drilling is currently underway in the northeastern area of the project and aims to extend mineralisation both along trend and at depth.

Upon completion of drilling in the northeast the campaign will move to the east of the project as highlighted in Figure 1.

A more detailed progress report, including drilling results, is expected to be provided next week.



ENTITLEMENT OFFER (RIGHTS ISSUE) CLOSING DATE EXTENSION

As announced on 29 July 2024, GTI is currently conducting the Entitlement Offer on the basis of 1 new share for every 5 existing shares held on the record date of 5.00pm on 12 August 2024, at an issue price of A\$0.004 per new share to raise up to approximately A\$2.0 million (before costs), together with one (1) free attaching new option for every three (3) new shares subscribed for and issued. Each new option will have an exercise price of \$0.01 and entitle the holder to subscribe for one (1) new share before their expiry four years from their date of issue.
