

CORPORATE GOVERNANCE STATEMENT 2024

The Board of Great Western Exploration Limited ("Board") is committed to ensuring that the Company's obligations and responsibilities to its various stakeholders are fulfilled through its corporate governance practices. The directors of the Company ("Directors", being either "Non-Executive Directors" or Executive Directors") undertake to perform their duties with honesty, integrity, care and due diligence, to act in good faith in the best interests of the Company in a manner that reflects the highest standards of corporate governance.

The Company's Board is committed to a high standard of corporate governance practices, ensuring that the Company complies with the Corporations Act 2001 (Cth), ASX Listing Rules, Company Constitution and other applicable laws and regulations.

Since the introduction of the 4th edition of the ASX Corporate Governance Council's Principles and Recommendations and Best Practice (4th Edition of ASX Guidelines), the Board considered and approved amendments to the Company's Corporate Governance Plan (which includes the Company's Corporate Governance Charters and Policies) in September 2020 and September 2022, in line with the 4th Edition of ASX Guidelines.

On 12 September 2024, the Board reviewed the Company's Corporate Governance Plan. Following this review, the Company's Corporate Governance Plan was put up on the Company's website during the September 2024 Quarter.

Corporate Governance Compliance

Since September 2020, the Company has followed the recommendations in the 4th Edition of ASX Guidelines where the Board has considered the recommendations to be an appropriate benchmark for its corporate governance practices.

Where, after due consideration, the Company's corporate governance practices depart from a recommendation in the 4th Edition of ASX Guidelines, the Board has offered full disclosure and reason for adoption of its own practice, in compliance with the "if not, why not" regime.

Listing Rule 4.10.3 requires an entity that is included in the official list as an ASX Listing to include in its annual report either a corporate governance statement that meets the requirements of that rule or the URL of the page on its website where such a statement is located. The corporate governance statement must disclose the extent to which the entity has followed the recommendations set by the ASX Corporate Governance Council during the reporting period.
