<u>Updated: 2024 Diggers and Dealers &</u> <u>Australian Gold Conference 2024 Presentations</u>

Kingsgate Consolidated Limited (KCN: ASX) provides clarification on the following points in respect of its 2024 Diggers and Dealers Presentation released on 6 August 2024 and its Australian Gold Conference 2024 Presentation released on 27 August 2024:

- 1. In both presentations, Debt disclosed on slide 4 (Corporate Overview) in the original release was A\$53.6m. This is now corrected to A\$72.8m to account for:
 - the inclusion of A\$11.4m in relation to preference shares in KCN subsidiary Akara Resources Public Company Limited. These shares are classified as equity in Thailand but are treated as debt under Australian Accounting Standards. The terms of the preference shares are detailed in Note 7 to KCN's Half-Year Financial Statements for the six months ended 31 December 2023; and
 - an upward adjustment of A\$7.8m to account for a transcription error in the debt balances at 31 July 2024.
- 2. An additional footnote that states "Debt disclosed has been updated to include preference shares in KCN subsidiary Akara Resources Public Company Limited, which are treated as debt under Australian Accounting Standards, and adjustment for a transcription error. The terms of the preference shares are detailed in Note 7 to KCN's Half-Year Financial Statements for the six months ended 31 December 2023."


