STRANDLINE TO BUILD COBURN AIRSTRIP

Airstrip will further improve efficiency at WA minerals sands project while aiding worker retention

Strandline Resources Limited (ASX: STA) (Strandline or the Company) is pleased to advise that it continues to drive efficiencies at its Coburn mineral sands project. The Northern Australian Infrastructure Facility (NAIF) will advance \$5m under the existing facility for construction of a new airstrip and associated infrastructure, located approximately 17 kms from the Coburn site.

Strandline Managing Director Jozsef Patarica said: "The Strandline team is making excellent progress in implementing our strategy to improve the operational and financial results at Coburn.

"A key part of this plan involves driving greater efficiencies, which includes retaining staff.

"Currently, a significant portion of our employees and contractors have to drive 3 hours or more to the Coburn site.. The airstrip will significantly reduce the time that employees and contractors spend on the road, leading to greater efficiencies and improved worker retention.

"On behalf of the Company, I wish to acknowledge the hard work of the Strandline team to continuously improve operating performance at Coburn. The continued support of our lenders and in particular NAIF in advancing this funding reflects the progress being made by the Strandline team. We thank the lenders for their support".

The facility will be utilised in multiple draws, with the first draw to be in an amount of A\$2.5m, and is subject to satisfaction of customary conditions precedent.
