

## Introduction

Nimy Resources Limited (“**Nimy**” or “**Company**”) is committed to implementing sound standards of corporate governance. As the Board acts on behalf of and is accountable to shareholders, the Board seeks to identify and meet the expectations of shareholders, as well as other regulatory and ethical expectations and obligations.</p> <p>In addition, the Board is responsible for identifying areas of significant business risk and ensuring arrangements are in place to adequately manage those risks. The Board seeks to discharge these responsibilities in a number of ways.</p> <p>The responsibility for the operation and administration of the Company is delegated by the Board to the executive directors and the key management team. All decisions relating to employees is based strictly on merit, without regard to gender, ethnicity, age, relationship status or any other irrelevant factor not applicable to the position. It is the Board's responsibility and objective to embrace diversity when determining the composition of the Board, senior management and employees.
