- 1. 87,002,652 unlisted free attaching options exercisable at 8.0 cents each and expiring on 15 July 2025 were issued to the recipients of Tranche 1 Placement Shares; and
- 2. 50,689,656 unlisted free attaching options exercisable at 8.0 cents each and expiring on 15 July 2025 were issued to the recipients of Tranche 2 Placement Shares.
