West Coast DOCA Executed

The Deed Administrators* (**“the Administrators”**) of Calidus Resources Limited (Receivers and Managers Appointed) (Subject to Deed of Company Arrangement) (ASX:CAI, “Calidus”) and its subsidiaries in the attached schedule A (**“Companies”**), are pleased to confirm that Deeds of Company Arrangement from the West Coast group of companies (**“West Coast DOCAs”**) have now been executed for the Companies¹. Three of the DOCAs have now also effectuated, as noted in Schedule A.

Further details of the West Coast DOCAs are contained within the Administrators’ Report pursuant to Section 75-225 of the Insolvency Practice Rules (Corporations) 2016 dated 18 September 2024 (“VA Report”) which is available online via the Creditors Portal maintained by the Administrators at: <https://www.fticonsulting.com/creditors/calidus-resources-group>.

The Deed Administrators and West Coast group of companies are now working to complete the conditions precedent to the remaining West Coast DOCAs – namely the progression of an application pursuant to section 444GA of the Corporation Act 2001 (Cth) (“Act”) which seeks to provide the DOCA Proponents with 100% of the issued equity in Calidus Resources (**“444GA Application”**).

Shareholders will be updated on the 444GA application, and Court process in due course.
