

Issue of Shares & Cleansing Notice

White Cliff Minerals Limited (White Cliff or the Company) advises that it has today issued 200,000,000 new ordinary shares at \$0.025 per share following settlement of a \$5 million capital raising (before costs), as announced on 9 October 2024 ("Placement Shares"). The Company has also issued 75,000,000 options exercisable at \$0.04 expiring 16 October 2027 as part of the capital raising, per the Appendix 2A and Appendix 3G released today.
