Operational Updates

Successful Shipping of First Mest Water Ammonia Reduction Unit

The first evaluation unit for Mest Water's ammonia reduction program was successfully shipped to Europe following comprehensive high-temperature testing in Sprintex's custom-built 'hot test cell'. Over the next few weeks, 19 more units will be delivered, completing the A\$1 million evaluation phase. Sprintex holds a letter of intent from Mest Water to develop additional larger and smaller compressors to serve a range of farm sizes across Europe. Mest Water has also secured a 31,000m³ factory to meet increasing demand from the 800,000 farms that need to comply with stringent European emission regulations, with Sprintex compressors playing a crucial role in reducing ammonia emissions.

Industrial Success: Qunying Corporation Case Study

In a successful trial with Qunying Corporation, a leader in the Chinese textile industry, two of Sprintex's G15 7.5kW blowers replaced older Side Channel Blowers (22kW and 18kW units). This resulted in a **69% reduction in electricity consumption**, with the G15 units operating at only 11.1kW combined. This energy-saving achievement translates to annual cost savings of approximately A\$1.25 million per factory, with a payback period of just two months. Qunying operates multiple factories, each using 62 blower installations, positioning Sprintex as a key player in the industry's transition to energy-efficient technology.

Ongoing Trials and Growing Market Demand

Sprintex's G Series blowers are currently being trialled across several industries, with notable success in reducing energy consumption and improving operational efficiency. The blowers' smaller, lighter designs and intelligent control systems have impressed many users, driving significant market demand as more companies recognize the operational and cost-saving benefits of the technology.
