

# Completion of Phase 1 program at Isabella Project with spodumene-bearing pegmatite trends over 1km

#### **HIGHLIGHTS**

- Successful completion of Phase 1 program at the Isabella Lithium Project, Lithium Valley,
   Brazil:

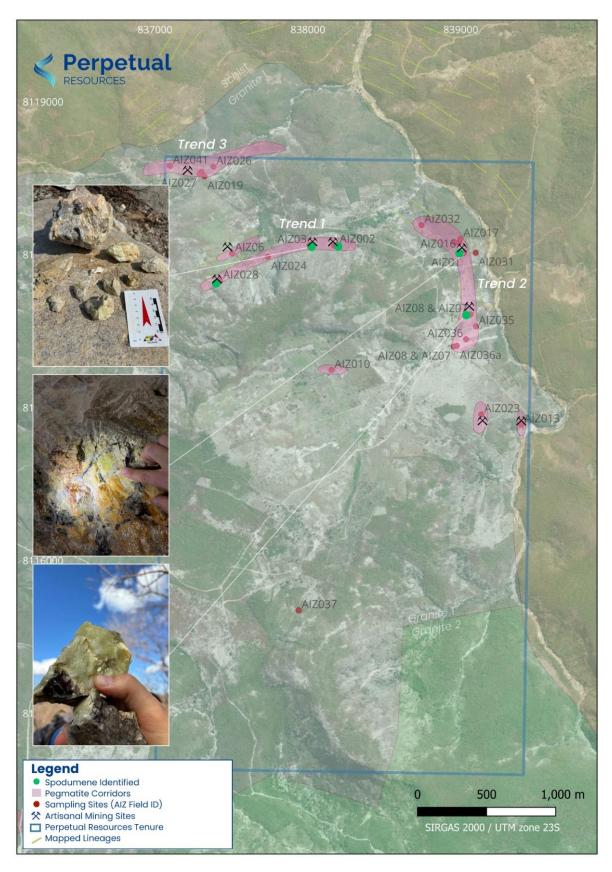


Figure 5: Map showing sampling locations, identified spodumene occurrences, artisanal workings, and pegmatite trends, with an inset photo from field sample work at the Isabella Project. <sup>5</sup>

  - Multiple spodumene (See Figure 5) occurrences identified, with mineralised trends exceeding 1km and open along strike.
  - Additional targets indicating potential parallel structures outside the main corridors, supporting evidence of further potential occurrences within the license area.
  - Extensive artisanal workings continue to guide and fast-track exploration understanding via access to subsurface geology with tunnels extending up to 150m.
  - Multiple batches totalling 88 rock chip samples to be received by labs in Brazil with results expected over the next in 4-8 weeks.

- Pre-acquisition rock chip sampling by Perpetual has already confirmed high grades of up to 5.62% Li<sub>2</sub>O from artisanal workings<sup>2</sup>.
- Perpetuals' Isabella license is located adjacent to two confirmed spodumene projects;
  - 0.5 km from Atlas Lithium's flagship Das Neves Project (NASDAQ:ATLX, Market Cap: US\$110 million), where an intersection of 1.47% Li<sub>2</sub>O over 95.2 meters was reported. Atlas

Lithium is currently constructing a lithium processing plant at Das Neves, which is expected to come online in Q4 2024.<sup>3</sup>

- <3km from the Sigma Lithium's (NASDAQ:SGML, Market Cap: US\$1.4 billion) Sao Jose Project which is an advanced spodumene exploration project.
- Perpetual expects to report the first set of rock chip results within ~2-4weeks, with
  exploration efforts ongoing targeting identification of drill targets for a maiden drilling
  campaign in 1H 2025.
- Perpetual is undertaking additional reconnaissance trips in November to continue target development and initiate environmental and local landowner approvals, advancing the formal drilling approval process.

**Perpetual Resources Ltd ("Perpetual"** or "the **Company") (ASX: PEC)** is pleased to provide an update after the completion of its maiden exploration program at the recently acquired Isabella Lithium Project, located in Brazil's prolific Lithium Valley.

The program was centred on a high-impact sampling campaign, targeting known spodumene-bearing artisanal workings while expanding exploration across the broader license area. The surface reconnaissance aims to identify high-potential LCT-bearing pegmatite drill targets, which will position the Isabella Project as a leading lithium exploration opportunity in Brazil's Lithium Valley, adjacent to other large, advanced spodumene projects.

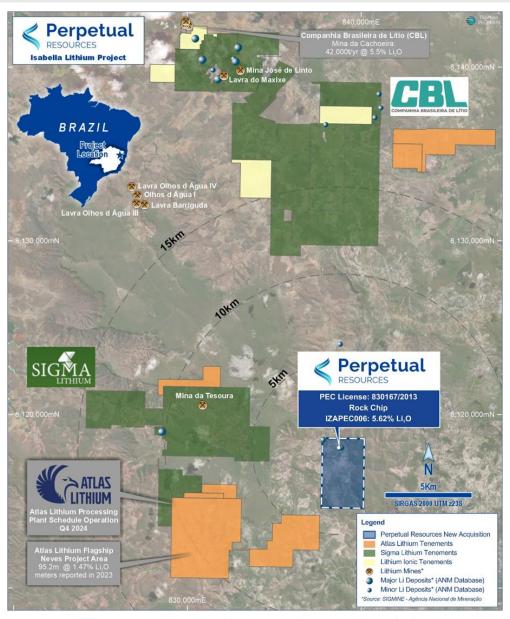


Figure 6 - Regional map of Isabella Project area adjacent to Atlas Lithium and Sigma<sup>678</sup>.

#### **Key Findings Highlight Project Prospectivity**

Perpetual has developed a strong initial technical understanding of the Isabella Project, underscoring its high potential for lithium mineralization. Spodumene occurrences have been confirmed at five key locations along Trends 1 and 2 (See Figure 5), following well-defined lineages. Additionally, multiple outcrops and artisanal workings have revealed mineral assemblages, including green tourmaline (elbaite) and cleavelandite, both recognized as strong indicators of lithium-enriched environments.

With over 30 artisanal mines and workings within the license area, previously focused on pegmatites for green tourmaline and other precious gemstones, Perpetual believes these historical workings provide a valuable foundation for interpreting pegmatite geometry, mineral assemblages, and broader regional prospectivity. From a targeting perspective, these findings offer multiple opportunities to test across a broad, scalable area.

#### **Background to the Isabella Project**

Perpetual's acquisition of permit 830167/2013 in July 2024 marked a significant advancement in Perpetual's Brazilian lithium exploration efforts. This permit included multiple spodumene-pegmatite occurrences and several historical

artisanal mining areas, with tunnels extending up to 150m, exposing interpreted LCT-bearing pegmatites suitable for initial testing.

The Isabella Project has confirmed high-grade lithium mineralization, with rock-chip assays revealing *values up to 5.62% Li<sub>2</sub>O*. Refined structural mapping has interpreted multiple high-confidence spodumene-pegmatite trends extending up to 1,000m and open along strike, delineated by artisanal workings targeting the pegmatites. Over 30 artisanal excavations have been identified, featuring substantial underground workings. The current exploration program is expected to delineate near-term drill targets, which are expected to be targeted by Perpetual in 1H 2025.

#### **Next Steps**

Perpetual is undertaking additional reconnaissance programs at the Isabella Lithium Project in November, which will continue to target known and prospective LCT-bearing occurrences. Efforts will also include an initiation of environmental and local landowner approvals, as well as advancing the formal drilling approval process. Initial laboratory test results are expected in the next 2-4 weeks, with further results over coming 4-8 weeks.

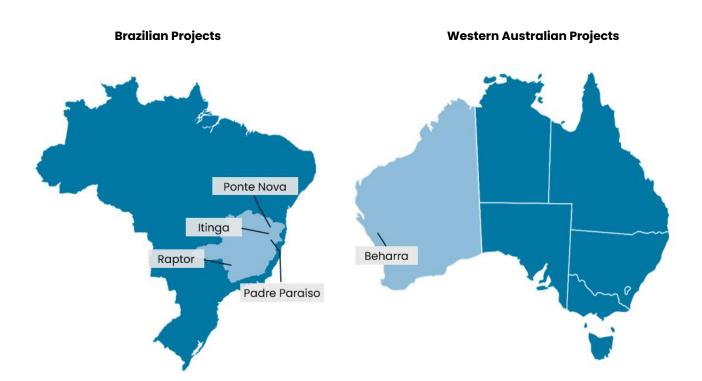
#### **About Perpetual Resources Limited**
