# Connected Minerals Limited – (ASX: CML) – Anticipated Reinstatement to Quotation

## **Description**

It is anticipated that the securities of Connected Minerals Limited ('CML') will be reinstated to quotation at 10:02:15am (+/- 15 seconds) AEDT on Friday, 25 October 2024, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

CML raised \$5,092,475 pursuant to the offer under its Second Replacement Prospectus dated 19 September 2024 by the issue of 25,462,375 shares at an issue price of \$0.20 per share.
