ENCOURAGING RESULTS FROM FIRST HOLE AT GLENLOGAN

Key Points

- Assay and petrography results received from first hole at Glenlogan
- Main magnetic anomaly is an alkaline gabbroic diorite, intruded by later quartz diorite porphyry ("QDP") dykes that increase in abundance downhole
- The last 300 metres of the hole contains:
 - o increasing QDP dykes, hydrothermal alteration and disseminated pyrite
 - increasingly anomalous levels of copper, gold and other chalcophile/pathfinder elements
 - Widespread presence of very fine grained late magmatic/hydrothermal chalcopyrite intergrown with propylitic-style alteration assemblage
- Late magmatic/hydrothermal chalcopyrite and consequent elevated copper in and around QDP dykes suggests they may be fertile and may represent the fringes of a nearby potentially mineralised porphyry intrusion as yet untested by drilling
- Various geophysics options being assessed to assist in targeting future drilling
- Ten land access agreements signed to facilitate future geophysics and drilling

S2 Resources Ltd ("S2" or the "Company") advises that its wholly owned subsidiary, Red Star Resources Pty Ltd ("Red Star"), has received assay and detailed petrography results from its first diamond drill hole at the Glenlogan project in the Lachlan Fold Belt of New South Wales, where it is earning up to an 80% interest from Legacy Minerals ("Legacy").

The assay and petrography results indicate that the main targeted magnetic anomaly is an unmineralized alkaline gabbroic diorite ("AGD") intrusion, but that the numerous later quartz diorite porphyry ("QPD") dykes that intrude the lowermost 300 metres of the hole have characteristics that may indicate potential for porphyry copper-style mineralisation in a nearby intrusive body as yet untested by drilling.




Figure 1: downhole abundance of (L to R) copper, gold, bismuth, tellurium and selenium in SGLD0001W1, showing increasing abundance of these metals towards the end of hole, directly associated with later quartz diorite porphyry dykes (yellow and orange colours on the drillhole trace) and the alteration of the earlier alkaline gabbroic diorite around these (pale purple). The unaltered AGD is shown as dark purple and the younger unconformable cover sequence as blue and green on the hole trace.

Assays show that the last 300 metres of the hole, and particularly the last 100 metres, have subtle but distinctly elevated levels of copper, gold, bismuth, tellurium and selenium, with 200-600ppm copper and 10-30ppb gold accompanied by other chalcophile/pathfinder elements (see Figure 1).

The anomalous zones are broadly correlated with increased concentrations of disseminated pyrite and the highest concentrations are specifically associated with the later quartz diorite porphyry dykes that intrude the main alkaline gabbroic diorite, and the alteration zones immediately around them.

Detailed petrographic studies of numerous samples have also confirmed that the copper occurs as disseminated fine grained chalcopyrite intergrown with other secondary alteration minerals including chlorite, amphibole, epidote, pyrite, magnetite, albite and hematite (see Figure 2). This assemblage indicates that the chalcopyrite formed from late hydrous magmatic to early prograde hydrothermal fluids, which is consistent with how porphyry copper mineralisation is typically formed.



Figure 2: photomicrograph of sample 1370002.20 from 1,295.2 metres, showing fine grained chalcopyrite intergrown with secondary propylitic-style alteration minerals. Whilst only present in trace quantities, the importance of the intergrowth of chalcopyrite with distal porphyry-style late magmatic/hydrothermal stage alteration minerals is that it suggests that the parent intrusion (the source of these QDP dykes) is fertile (ie, enriched in metals, sulphur and water) and has produced a late stage metal and sulphur-rich fluid of the kind which can form copper and/or gold enriched zones.




Figure 3: cartoon section showing the increasing copper anomalism associated with increasing disseminated pyrite and later quartz diorite porphyry dykes in hole SGLD0001W1. The increasing incidence of copper, gold, other chalcophile/pathfinder elements, disseminated pyrite and quartz diorite porphyry dyking suggests the hole may be approaching a mineralised porphyry intrusion flanking and intruding the main alkalic gabbroic diorite intrusion. This target intrusion could extend upwards to the base of the unconformity at a vertical depth of ~350 metres.

The copper-gold anomalism towards the end of the hole does not necessarily mean that the target zone is deeper because it is possible that this hole may have drilled close to the lower parts of a prospective intrusion that extends upwards towards the unconformity, which occurs at a vertical depth of about 350 metres. Mineralised intrusions often form as slender fingers rising from the flanks of



larger intrusions, so the target zone may infact occur in the 350-1,000 metre depth range (see Figure 3).

Now that the Company has established that the magnetic anomaly that it originally tested is not the prime target and that the actual target may be an adjacent intrusion with a spatially related halo of pyrite alteration, a variety of geophysical techniques are being assessed which may assist in identifying the three dimensional location of alteration as a way of sharpening the focus for a follow up drill hole.



These geophysical survey options require deployment over a broader area than that required for actual drilling so are dependent on gaining access to larger area. To this end, the Company is negotiating access with landholders and has now signed ten agreements. The extent of access will in part influence which types of survey are undertaken, and such a survey is likely to take place in December or January, once crops have been harvested.

Project background

The Glenlogan project comprises an exploration licence (EL9614) covering 85 square kilometres in the highly endowed Lachlan Fold Belt of New South Wales, which contains a number of major gold/copper deposits, including Newmont's Cadia-Ridgeway operations (36.6Moz gold/8.3Mt copper), Evolution Mining's Cowal (8.8Moz gold) and North Parkes (3.3Moz gold/2.9Mt copper) mines, and Alkane's Tomingley (1.8Moz gold) mine and Boda (8.4Moz gold/1.5Mt copper) deposit.

S2 is earning up to an 80% interest in this project from ASX-listed Legacy Minerals ("Legacy"). Following the consideration of 1 million S2 shares issued to Legacy on signing, the agreement comprises an earnin and joint venture phase, with key terms as follows:

- Minimum commitment is to drill the Shellback magnetic anomaly within 12 months and to undertake 1,200 metres of diamond drilling (completed)
- S2 can spend A\$2 million within 2 years of signing to earn a 51% participating interest
- Following this, S2 can elect to spend a further A\$4 million within a further 3 years to earn an additional 19% interest for a 70% participating interest, including a minimum of 8,000 metres of diamond drilling

At the earn-in point:

- A joint venture will be formed with S2 having up to a 70% participating interest and Legacy having a 30% participating interest
- Legacy will have a one-time choice to retain its participating interest or to convert this to a 20% carried interest
- In the circumstance of a participating interest, Legacy must contribute or dilute
- Should Legacy's participating interest drop below 10%, its interest will revert to a 2% net smelter return (NSR) royalty
- S2 can buy down half of this royalty (ie, 1%) for A\$3 million at any time up to 3 years from a joint venture being formed
- In the circumstance of a carried interest, S2 will have an 80% interest and Legacy's 20% interest will be funded by S2 up to the commencement of commercial production, with this being will repayable from 70% of the production revenue attributable to Legacy's 20% interest in a mining operation

Drill holes CRB7 (56m) and CRB57 (96m) were strongly altered by chlorite-sericite-quartz-zeolite, comparable to the propylitic alteration commonly found distal to porphyry systems. Drill holes did not reach the Ordovician basement which is interpreted to be at approximately 450m depth. Post mineral intrusions are common in large, long lived mineral systems and as such the observation of monazite in drilling is considered encouraging for a large and older intrusive complex at depth in association with the magnetic anomaly.
		Rio Tino held the project between 1994-1997, undertaking Magnetic modelling which suggested the magnetic anomaly was approximately 800m below surface, thus the likelihood of a large-scale mineral system associated with the magnetic source was not likely to be amenable to shallow mining methods and drilling was therefore not conducted.
Geology		The Glenlogan Project is in the Central Lachlan Fold Belt, NSW, which hosts world-class Au-Cu orebodies including the Cadia-Ridgeway, Northparkes and Cowal Mines. The project is considered prospectve for copper-gold porphyry intrusions and/or associated skarn style copper-gold.
		The exploration tenement covers the western margin of the Siluro-Devonian Cowra trough, located in the Forbes Anticlinal Zone of the Lachlan Fold Belt. The Ordovician Macquarie Arc volcanics are interpreted to be buried beneath these later geological units.

The "Shellback" magnetic anomaly is modelled to intrude to within 450 – 600m of surface, suggesting the body has not intruded into the overlying Silurian sequence, thus suggesting the magnetic body was emplaced during the early Silurian to late Ordovician, which is a similar timing to the Cadia Valley porphyry complex (435.9 – 459.7Ma). It is considered that the Silurian age cover sequence will have been critical in the preservation of any potential porphyry mineralisation across the Glenlogan Project, as it was for the preservation of the Cadia Valley porphyry district.
		Comparable aeromagnetic responses to those present at the Glenlogan project have been reported at other major porphyry Cu-Au deposits, including: Cadia East (AUS), Grasberg (IND), Alumbrera (ARG), and Buenavista Del Cobre (MEX). The strong magnetic response suggests a discrete central magnetic high possibly due to chalcopyrite-bornite-magnetite mineralisation, associated with a porphyry proximal potassic alteration zone, surrounded by an annular magnetic low due to magnetite destructive hydrothermal alteration of surrounding rock, features that are characteristic of globally important Cu-Au porphyry deposits.
