September 2024 Quarter Activities Update

Telecommunications innovator Vonex Limited (ASX: VN8) provides the following update and Appendix 4C Quarterly Report for the three months ended 30 September 2024 (Q1 FY25).

In the past quarter Vonex continued its focus on the business, ensuring systems and operations delivered value for our customers, while maintaining focus on cost and controls. This process continues to drive increased operational strength in the business, improving the customer experience, employee capability and quality of work, and increasing the intrinsic value of the Company, to the ultimate benefit of our shareholders.

In Q2 FY25 Vonex is releasing a wholesale version of Link2.0 offering Vonex wholesale customers autonomy in managing their customers' vPBXs. Link2.0 has been a real success and a credit to the Vonex development team.

Due to the escalating cost of software for the upgrade to SOG (the 'sign on glass' project), Vonex has changed tack to enhance the existing platform - which will not only further enhance the customer experience, but will deliver greater value to our shareholders. Customers will see the improved automation in Q2 FY25.

The Vonex NBN network insource project has completed stages 1 and 2, thanks to the tenacity and dedication of our technical department. The next stage will be completed in Q2 FY25, with the final stage in Q3 FY25. Other data product enhancements will also continue to be delivered in FY25.

As part of our ongoing mission to provide innovative solutions to our customers, including wholesale and their end users, Vonex continues to actively investigate AI enhanced product opportunities for Q4 FY25.

The Company continues to maintain a very close eye on cashflow, and is pleased to have maintained double digit % EBITDA margin for the last quarter.

Sales have been consistent in the period with expectations of increased growth in FY25, given the overall strengthening of the business and improvements to the ease of dealing with Vonex as a supplier.

Our Channel, Retail, Residential and Wholesale customers are extremely important to our future. The Company is never complacent about our customers and is delighted to be able to deliver the marked continuing improvements in customer experience over the past quarter.

During the quarter, the Company also dealt with the ongoing Scheme of Arrangement with MaxoTel to acquire all of the shares of the Company. Subsequent to the end of the quarter, the Company received MaxoTel's follow on unconditional on-market takeover offer. This was followed more recently by MaxoTel's improved unconditional on-market takeover offer, offering \$0.044 for each Vonex share.

The Company has released to the market its Target's Statement in response to the MaxoTel offers, which confirms the Board's recommendation that shareholders ACCEPT the \$0.044 MaxoTel unconditional market offer.

The Company also responded to Swoop (ASX: SWP) again announcing that they would make a bid for the Company, but not actually doing so. While the Company is yet to see the detail of any takeover offer, the proposed terms (including conditionality around financing, a 51% minimum acceptance condition, and uncertainty as to how Swoop would deal with the potential refinancing of the existing Vonex debt if that was required on a change of control), meant that the Board confirmed its view that the announced potential bid would not be superior to the MaxoTel bid in any case.

Payments to related parties in Q3 FY24 were \$67k, encompassing Chair and Non-Executive Director fees.
