NeuroScientific Biopharmaceuticals Ltd (ASX: **NSB**) ("NeuroScientific" or "the Company") today submitted its Appendix 4C and quarterly activity report for the period ended 30 September 2024.

QUARTERLY ACTIVITY REPORT

Commencement of IND-enabling studies in advanced glaucoma

After a Pre-Investigational New Drug Application (pre-IND) meeting with the U.S. Food and Drug Administration (FDA) in June, NeuroScientific has begun a series of IND-enabling studies. These studies are focused on evaluating the safety (toxicology), how the drug is processed in the body (pharmacokinetics), and the optimal formulation of EmtinB for administration directly into the eye (intravitreal administration).

To support this research, NeuroScientific has first engaged a leading global bioanalytical laboratory to conduct an *in vitro* melanin binding study. This study, expected to finish between late 2024 and early 2025, will provide crucial information for selecting the right breed of rabbits for upcoming toxicology and pharmacokinetics studies. Different rabbit breeds have varying levels of melanin in their eyes, and understanding how the drug binds to melanin helps ensure that the chosen animal models provide accurate data for predicting how the drug will behave in humans.

These follow-up toxicology and pharmacokinetics studies with animals are planned to begin in early 2025 and finish by mid-2025, bringing NeuroScientific closer to securing FDA approval for its first-in-human clinical trials.

New Opportunities

NeuroScientific continues to evaluate a range of promising new opportunities to expand and enhance its portfolio.

Corporate

The Company announced on 2 October 2024 that it would be holding its Annual General Meeting of Shareholders on Wednesday 6 November 2024.

Quarterly Cash Flow Summary

NeuroScientific's cash position was \$4.74 million as at 30 September 2024. The Company has maintained a strong cash position with expenses continuing to be carefully managed.

Research and development activity payments during the current quarter were \$37k (\$93k for the prior quarter ("PQ")). Staff costs for the quarter were \$67k (PQ - \$99k). Administration and corporate costs were \$143k (PQ -\$94k).

Payments to related parties during the June 2024 quarter totalled \$67k and relate to Director fees, salaries and superannuation.

The level of net cash burn for the December 2024 quarter is expected to be at similar levels as for the September 2024 quarter, as the Company continues to define its, short-, medium-and long-term strategy.

About EmtinB™

EmtinBTM is a peptide-based compound that binds to surface-based cell receptors from the LDLR family, activating intracellular signalling pathways that stimulate neuroprotection, neuroregeneration and modulate neuroinflammation. EmtinBTM is modelled on a specific active domain of the complex human protein called Metallothionein-IIA, which is produced as part of the human body's innate immune response to cell injury.

Our preclinical research has established that EmtinB™ is highly specific and selective for its target receptor, safe and well tolerated at high concentrations.
