CAQ Holdings Limited September 2024 Quarter Activities Report

Operations Review

The property leasing business decrease in September 2024 Quarter. Leasing revenue totalled RMB2.3 million during the September 2024 Quarter, slightly down from RMB2.4 million in the June 2024 Quarter, representing a decrease of approximately 4%.

The status of the exhibition centre remained similar of the June 2024 Quarter, the system integration testing was suspended pending for new requirements raised out by the custom.

The existing vacancy (including areas subject to negotiation) rate being:

Warehouse (41,750m ²)	38%	(31% in June 2024)
Factories (17,784m ²)	55%	(64% in June 2024)
Exhibition Centre*	95%	(89% in June 2024)
Administrative Building	46%	(46% in June 2024)

Work is continuing on securing new tenants for all areas with a number of contracts under negotiation.

During the September 2024 Quarter CAQ's receipts from customers was \$391k (RMB1.8 million) which was down from the June 2024 Quarter \$412k (RMB2 million).

Financial

At the end of the Quarter the Group had cash at bank of \$0.21m.

Payments to director related parties and their associates during the quarter totalled \$Nil.
