SEPTEMBER QUARTER HIGHLIGHTS

First Lithium Limited ("FL1", or "the Company") is pleased to provide an update on its activities for the September 2024 quarter.

First Lithium Managing Director, Venkatesh Padala said:

"Receiving the drilling and assay results for the completed stage one drilling program in Mali, now sets the Company up for release of its maiden JORC mineral resource estimate (MRE), anticipated prior to end of 2024.

The MRE along with the pending license renewals are milestone events for FL1 and will allow the Board to take strategic actions on the next phase of the Project".

FINAL DRILLING RESULTS AND FURTHER HIGH GRADE Li₂O INTERSECTIONS IDENTIFIED¹

Series Two holes drilled as Reverse Circulation (RC) precollars and diamond tails to intersect targeted pegmatites under the Series One holes at depths of approximately 50 – 100m below surface. High grade analytical results were received for Series Two holes BRCD01 to BRCD15, with high grades from all the holes covering circa 1,200m strike on the Main Pegmatite body, at the Blakala prospect:

- BRCD12 with a 41.0m intersection @ 1.91% Li₂O (from 81.0m)
- BRCD04 with a 20.0m intersection @ 2.03% Li₂O (from 69.0m)
- BRCD01 with a 37.0m intersection @ 1.79% Li₂O (from 88.0m)
- BRCD07 with a 22.75m intersection @ 1.79% Li₂O (from 75.0m)



- BRCD09 with a 32.6m intersection @ 1.70% Li₂O (from 99.0m), Including a 14.0m intersection at 2.02% Li₂O (from 99.0m); and including a 10.3m intersection at 1.91% Li₂O (from 120.7m)
- BRCD11 with a 29.7m intersection @ 1.66% Li₂O (from 115.2m), including a 14.5m intersection at 1.91% Li₂O (from 115.2m); and including a 6.6m intersection at 2.79% Li₂O (from 138.3m)




Figure 1: Section showing the previously reported First Series BDFS03 on the Main Pegmatite; BDSF20 drilled from the Western Pegmatite through the Main Pegmatite at depth; and Second Series BRCD07 intersecting the Main Pegmatite, with the new results from the diamond drilling portion of BRCD07.

Pegmatite bands up to 10 m wide were intersected between the western pegmatite and the main pegmatite body and are now confirmed in the RC precollar holes¹ as having considerable lithium content (Figure 1). Blakala extension mapping and trenching, as well as mapping and trenching of numerous other targets on the Gouna licence, has taken place. Mineral Resource Estimation (MRE) and JORC Report process id being managed by Pivot Mining.

FINAL ASSAY RESULTS RECEIVED²




Figure 2: Locality and analytical results of Blakala First Series BDFS40 to BDFS46 diamond drill holes and Second Series diamond tail drill holes BRCD16 to BRCD36.






Figure 3: Section showing the previously reported First Series BDFS25 on the Eastern Pegmatite; and Second Series BRCD18 intersecting the Eastern Pegmatite at depth, with the new results from the diamond drilling portion of BRCD18.

Second Series holes drilled on the Eastern and Western Pegmatites, as well as the Southern extension of the Main Pegmatite on the Blakala Prospect, with Reverse Circulation (RC) pre-collars and diamond tails drilled to intersect targeted pegmatites under the First Series diamond holes at depths of approximately 50 – 100m below the surface. High grade analytical results were received for the Second Series diamond tails BRCD16 to BRCD21 drilled in the Eastern Pegmatite, with high grades from all the holes covering circa 400m strike (Figures 2,3):

- BRCD21 with a 24.00m intersection @ 1.53% Li₂O (from 129.0m)
- BRCD19 with a 28.59m intersection @ 1.51% Li₂O (from 117.0m)
- BRCD18 with a 9.00m intersection @ 1.62% Li₂O (from 117.0m)

High grade analytical results were received for the First Series diamond hole BDFS46 confirming the additional northern extension to the Eastern Pegmatite (Figure 2):

- BDFS46 with a 12.27m intersection @ 1.65% Li₂O (from 46.0m)




Figure 4: Section showing the previously reported (black on grey results) First Series BDFS38 on the southern extension of the Main Pegmatite; and Second Series BRCD25 intersecting the Main Pegmatite at depth, with the new results (black on yellow) from the diamond drilling portion of BRCD25.

High grade analytical results were received for the Second Series diamond tail BRCD25 drilled on the Southern extension of the Main Pegmatite, which shows the depth continuity of the Southern extension of the Main Pegmatite and is in addition to the excellent results reported for the Main Pegmatite Second Series drilling (*Figures 2,4*):

- BRCD25 with a 8.34m intersection @ 1.77% Li₂O (from 137.0m)




Figure 5: Section showing the previously reported (black on grey results) First Series BDFS17 on the Western Pegmatite; and Second Series BRCD28 intersecting the Western Pegmatite at depth, with the new results (black on yellow) from the diamond drilling portion of BRCD28.

High grade analytical results received for Second Series diamond tails drilled on the Western Pegmatite, showing the mineralisation at depth and the significant width of this pegmatite body (Figures 2,5):

- BRCD28 with a 25.64m intersection @ 1.68% Li₂O (from 137.0m); and
- BRCD36 with a 15.00m intersection @ 1.23% Li₂O (from 96.0m)

METALLURGICAL TESTWORK RESULTS³

An Li2O concentrate grade of 6.8% at a recovery of 80% was achieved with flotation testwork completed on a composite sample comprising selected pieces of core with the Spodumene making up 98% of the lithium mineralogy. The heavy liquid separation test resulted in a 93% spodumene content in the sinks fraction.




Figure 6: Location of Composite Sample drill holes

The composite samples were collected from twelve drill holes spaced over a 1,300m length of the Blakala Central, east and West pegmatites (*Figure 6*). The objective of the scoping study level metallurgical testwork is to identify and produce a spodumene concentrate suitable for sale on world markets. The metallurgical testwork program included the following:

- 1. Lithium Deportment;
- 2. Heavy Liquid Separation (HLS) Testwork; and
- 3. Flotation Testwork.

Li2O was the element of interest within this metallurgical testwork conducted at a scoping level and the results showed the head chemical analysis containing a grade of 1.93% Li2O. The samples examined are likely sourced from a granitic pegmatite, with spodumene as the predominant Libearing phase. The final concentrate with a targeted Li2O grade of 6-7% at a recovery of 70-80% was produced by a rougher test at 80% -212 μ m as the spodumene is relatively coarse grained, with 80% reporting to be coarser than 100 μ m.

The metallurgical testwork is being progressed concurrently with the Company's maiden JORC Mineral Resource Estimate. The metallurgical test work has determined the lithium concentrate recovery rates at Blakala, the results of which are extremely positive, and can be compared to those of neighbouring Leo Lithium (ASX:LLL) who recently sold their project with a valuation of circa \$1.3b.

PERMIT RENEWAL APPLICATIONS LODGED

Permits for both Faraba and Blakala were lodged within the required timeframes and were acknowledged as received by the Mali Mines Department. Renewals are expected to be granted once the Mali Mines Department recommence formal renewal operations, something that has been on hold for sometime to allow for the adequate adoption of the new Mining Law. Our local team in Mali is managing the process with the Mali government and believe the renewal process is advancing.

The Use of Funds table is a statement of current intentions, investors should note that the allocation of funds set out in the table may change depending on a number of factors including the results of exploration, outcome of development activities, regulatory developments and market and general economic conditions.

- 1. Exploration at the Mali Lithium Project is currently over the use of funds budget by \$80k. The variance is due due to an additional capital raising conducted during the period since re-listing on 28 September 2023.
- 2. Expenses of the offer is currently under the use of funds budget by \$311k. The variance was due to costs of the offer being over estimated and some budgeted costs being paid from existing cash reserves.
- 3. Corporate and administration costs include business running costs, director's fees and related party payments, ASX compliance costs and corporate expenses. Additional funds have been allocated to be spent for administration purposes due to an additional capital raising conducted during the 24-month period since re-listing on 28 September 2023.
- 4. Working capital is currently under the use of funds budget by \$552k. This is set aside as a reserve of funding for effective capital management.
- 5. In the June 2024 quarter, the Company completed a capital raising of \$2.16m (before costs) to advance exploration activities and provide working capital.
