The Receivers and Managers have advised Walkabout that they plan to operate the Lindi Jumbo Graphite Mine and processing plant on a business-as-usual basis while reviewing operating and recapitalisation options. The Receivers and Managers will work closely with Walkabout employees, suppliers, other secured lenders, and customers to continue operations and preserve value for all stakeholders.

The Receivers and Managers have secured a funding facility from Gemcorp of US\$10m which will be used by the Receivers and Managers to support WKT's ramp-up and to meet costs to ensure continuity of operations.
