## Consolidation of Share Capital and Change of Name

Australian Potash Limited (the Company) (ASX: APC) hereby advises that at the Company's Annual General Meeting held earlier today on 27 November 2024, shareholders of the Company approved a change in the Company's name to APC Minerals Limited and a consolidation of the Company's issued capital on a forty (40) for one (1) basis (Consolidation).

The Change in the Company's name to APC Minerals Limited has been registered with ASIC and it is expected that the change of name will be effective on ASX platforms early next week. The Company will provide an update when this has occurred. The Company's ASX ticker (ASX: APC) will remain unchanged.

The Consolidation reduces the number of APC's securities on issue to what is considered a level that is appropriate for the Company and its future plans.
