

Dear Sir/Madam,

**Re: Joyce Corporation Ltd (ASX: JYC) Correction – Form 604 Change in Substantial Holding**

I refer to the *Form 604: Notice of change of interests of substantial holder* I lodged with ASX on 25 October 2024 with respect to my voting power in Joyce (the **October Notice**). The October Notice incorrectly included 389,999 shares under the name JG Smetana. These shares are held by my sister-in-law, Judith Smetana (and not my wife, Julie Smetana). I do not have any power to control the right to vote attaching to, or the disposal of, the 389,999 shares held by Judith Smetana. The October Notice also incorrectly included 3,000 shares in the name of Adamic Pty Ltd, which were included in error. A corrected October Notice removing these holdings to reflect my voting power in Joyce (as at the date of the original October Notice) is attached to this letter.


