Anteris Technologies Global Corp. (formerly Anteris Technologies Ltd) (ASX: AVR) – Admission and Quotation

Description

Anteris Technologies Limited ('ATL') was admitted to the Official List of ASX on 24 March 2004.

On 13 August 2024 ATL announced that it had entered into a scheme implementation deed with Anteris Technologies Global Corp. ('ATGC') to pursue a re-domiciliation of ATL and its subsidiaries ('Anteris Group') from Australia to the United States of America by way of proposed schemes of arrangement with its shareholders under Part 5.1 of the *Corporations Act 2001* (Cth) ('Share Scheme') and its optionholders ('Option Scheme') (together, the 'Schemes'). ATGC will acquire 100% of ATL's issued shares, ATL optionholders will exchange their options in ATL for equivalent securities in ATGC, and ATGC will become the new ultimate parent company of the Anteris Group effectively redomiciling ATL to the United States of America.

On 4 December 2024 ATL announced that the Supreme Court of Queensland granted orders approving the Schemes.

On 5 December 2024 ATL announced that the Schemes were now legally effective and ATL's shares were suspended from trading on ASX from the close of trade.

On 13 December 2024 ATL announced that the conditions of the Schemes have been satisfied.

ATGC will be admitted to the official list of ASX today, 16 December 2024.

It is anticipated that the ATGC CDIs representing ATGC shares at a ratio of 1:1 (i.e. 1 CDI confers a beneficial interest in one fully paid ordinary ATGC share) will commence quotation at approximately 10:00am (AEDT) on 17 December 2024.

No funds were raised by ATGC in connection with its listing on ASX.

ATGC expects to raise US\$88.8 million under its initial public offering ('IPO') and listing on NASDAQ, which is scheduled to close on 16 December 2024 (US time). ATGC will release an ASX announcement confirming the closing of the IPO prior to the commencement of trading on ASX on 17 December 2024. ATGC's shares commenced trading on NASDAQ on 13 December 2024.
