Lodgement of ASIC Form 604 and correction of ASIC Forms 604

Maxo Telecommunications Pty. Ltd. ACN 129 852 526 (MaxoTel) hereby lodges an ASIC Form 604 -Notice of change of interests of substantial holder (Forms) in respect of the interests held by MaxoTel and 12223 Pty Ltd (Substantial Holders) in Vonex Limited (Vonex). This form shows that the Substantial Holders have total voting power in 48.27% of VN8's shares.

We refer to the Forms submitted from 8 November 2024 to- 9 December 2024 (inclusive). Since filing these Forms, MaxoTel has become aware of a discrepancy in the total voting power of the Substantial Holders referred to in each Form, arising from the incorrect recording of the Vonex shares acquired by MaxoTel on 30 October 2024 under its Takeover Bid in the Form dated 7 November 2024, which should have been recorded as "28,956", rather than "28,596".

MaxoTel has submitted corrected Forms with this announcement.

 - (b) any qualification of the power of a person to exercise, control the exercise of, the voting powers or disposal of the securities to which the relevant interest relates (indicating clearly the particular securities to which the qualification applies).
 See the definition of "relevant agreement" in section 9 of the Corporations Act 2001.
- (7) Details of the consideration must include any and all benefits, money and other, that any person from whom a relevant interest was acquired has, or may, become entitled to receive in relation to that acquisition. Details must be included even if the benefit is conditional on the happening or not of a contingency. Details must included of any benefit paid on behalf of the substantial holder or its associate in relation to the acquisitions, even if they are not paid directly to the person from the relevant interest was acquired.

- (8) If the substantial holder in unable to determine the identity of the person (eg. If the relevant interest arises because of an option) write "unknown".
- (9) Give details, if appropriate, of the present association and any change in that association since the last substantial holding notice.
