CYQ is therefore pleased to announce Adam Osseiran as the first appointment to our Advisory Board.

Adjunct Professor at the University of Western Australia, Adam was recently the Chair of Brainchip Holdings Limited' Scientific Advisory Committee (Jan 2020 to August 2024) and present member of the Beemotion.Al Advisory Board. Adam is also the Co-Founder and Director of Innovate Australia, a not-for-profit organisation responsible for the promotion of innovation in Australia. Adam's knowledge of Neuromorphic Computing and the Hardware components of Edge Al will help Cycliq in the design of vision applications both in-camera and via control box modules that can elevate the features of our current products and expand use cases across and beyond cycling.
