Results of Annual General Meeting

Aurora Energy Metals Limited (Aurora or the Company) (ASX:1AE) confirms that all resolutions put to shareholders at the General Meeting held today were passed by way of a poll.

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act, details of the proxy votes received and the poll results for each resolution, are attached.

Eagle Option Agreement

Aurora shareholders were voting to approve the proposed disposal of the Aurora Uranium Project (AUP) under an Option Agreement with Eagle Energy Metals Corp. (Eagle), a US-based company specialising in domestic energy project development, which was first announced on 19 November 2024.

The shareholder approval satisfies the key condition under ASX Listing Rules 11.2 and 11.4.1, enabling the grant of the Option to Eagle.

Following this approval by shareholders, the US\$300,000¹ (approximately AU\$484,000) Option Payment previously deposited with the appointed escrow agent, will now be released to Aurora.
