Additional R&D tax rebate received for improvements to manufacturing process

Highlights

- Tax rebate of circa AUD\$404,300 received for R&D activities conducted at Henderson facility
- Funding reflects improvements made to PureGRAPH® manufacturing and production processes
- Additional tax rebate follows receipt of circa AUD\$166,000 for R&D work completed in the United Kingdom, bolstering the Company's finances

First Graphene Limited (ASX:FGR; "First Graphene" or "the Company") has received a tax rebate for research and development (R&D) work conducted at its Henderson facility in Western Australia.

The tax rebate of approximately AUD\$404,300 was delivered following a series of work completed by the Company to improve manufacturing of its in-demand PureGRAPH® products.

This includes implementation of a Retsch Mill to enhance the milling process, with the new technology improving efficiency by 60% and making the process 67% more cost effective.

The rebate also covers the Company's Electrochemical Cell Optimisation trials which investigated altering the cell and electrode design to deliver improvements to the manufacturing process.

Results from the most recent phase of trials include a 32% increase in the overall production rate and a 25% reduction in power consumption, compared to the first phase.

The funding was also received for the collaborative work by the Henderson production and the UK-based R&D teams to manufacture graphene oxide, which is used in water purification and desalination, potentially opening new opportunities for the Company.

This second tax rebate supports the AUD\$166,000 recently received for R&D work conducted in the United Kingdom, as announced by the Company on January 22.

This supplemented paid development work by clients across a variety of applications, as well as a range of UK grant-funded programs including Innovate UK's A\$3.7 million HyPstore project and Analysis for Innovators scheme, valued at more than A\$192,000.

Research and development remain a key area of focus for First Graphene as these activities assist with further solidifying the Company's pathway to commercialisation in new and emerging markets.
