The shares are being issued in part consideration for the acquisition of Spatial Vision Innovations Pty Ltd. Refer to Veris₂ ASX announcement dated 30 January 2025 for further details. This amounts to a maximum of 16,666,667 shares assuming the Issue Price is the floor price of \$0.03.

Additionally, shares to the value of \$250,000 (being \$125,000 for each milestone and determined at the Issue Price) will be issued to the vendors as deferred consideration if the milestone hurdles are satisfied for FY26 and FY27. This amounts to a maximum of 4,166,667 shares for each milestone assuming Issue Price is the floor price of \$0.03
